As an agent registered with GETI Tasmania, we value your loyalty.

Our agent incentive program ensures we can help your agency grow and support your clients.

You can receive up to 25% commission and a bonus payment of \$2,000 per student.

Once you are a registered Education Agent with GETI, you are eligible for the rewards program.

Regardless of the status, GETI is committed to supporting your agency in any way we can.

Our commitment to you

All agents receive:

- A certificate of registration and status
- Link to your agency on our website
- Up to date program information and promotional materials
- Access to our online application system
- In-country visits and training from GETI staff

SILVER agents:

- Commission of 15% per student on first year of tuition

GOLD agents:

- Commission of 20% per student on first year of tuition
- \$2,000 bonus payment per student (long term student visa holders only)

PLATINUM agents:

- Commission of 25% per student on first year of tuition
- \$2,000 bonus payment per student (long term student visa holders only)

GETI Education Agent Rewards program commission rates are:

Terms and Conditions

1. To qualify for GETI Education Agent Rewards program, Education Agents must first be registered with GETI. Education Agent agreements are reviewed annually as part of GETI's requirements under the ESOS Act 2000.

2. Each student recruited must satisfy the genuine student criteria of Australia's Department of Home Affairs. Once a student commences their education in Tasmania and is assessed as genuine, they are added to the Education Agent reward tally.

3. The commission rates vary according to a category of students. The commission rate in the GETI Education Agent Rewards program apply only to students studying in Tasmania on an Australian student visa subcategory, for a minimum of 6 months. Other categories are paid at a standard rate of 15% commission and some categories contribute to the overall Education Agent tally. Please refer to the chart above.

4. Rewards ratings for Education Agents will be reviewed annually, based on the number of new students recruited to Tasmanian Government education providers over a 12 month period, based on the Western

calendar year from 1 January – 31 December. The performance in the current calendar year determines the Education Agent reward rating for the following year.

5. Commission payments are based on a proportion of the year's tuition fees only, payable upon the Education Agent invoicing GETI Tasmania following the commencement of student study in Tasmania. Invoices must be received within 3 months of student commencement.

6. Commission does not apply to administration or homestay fees.

7. Terms and conditions are subject to change. In situations of dispute, GETI reserves all rights.
