## Please note:

- Before enrolling in a school, all temporary residents must apply for an Authority to Enrol letter (AtE). The application form is available on our website <a href="https://www.study.tas.gov.au/trp">www.study.tas.gov.au/trp</a>.
- All permanent visa holders are exempt from obtaining GETI Authority to Enrol and paying application and tuition fees.
- A non-refundable application fee per student applies to all TRP applications.
- <u>School levies</u> are fees billed by, and payable directly to, the enrolling school and are not the same as tuition fees.
- Temporary residents who are 18 years old at the time of commencement may be fee liable regardless of visa subclass.

- Fee rates, and Tuition Fee status are subject to change.
